All owners of the Irvin EB80 parachute, commonly used in the T67 aircraft, should be aware of the following Technical Instruction and Service Bulletin.

Irvin-GQ TI 01/013 and Capewell SB CW03-001


There have been cases of the ripcord pin breaking, which could cause a parachute system to malfunction.

The TI/SB are applicable to the Irvin EB80 parachute – see attached letter, even though it has not been included on the “Equipment Affected” listing. It was for this reason that SAL have issued this Information Bulletin.

If you are unaware of the TI/SB and use the EB80 parachute then you should contact Irvin-GQ for further advice.
